

Select High Confidence Suggestions

Users can quickly review the top suggestion from the Seahorse suggestion engine using the bulk review feature. Tags are applied with a single click and, where a more thorough investigation of the available tags is required, users can inspect the list of tags in more detail.

Add Filing

Step 2 - Select Filing Type

- Create a new filing from scratch.**
- Create a new filing based on a previous filing for the same filer.**
Use this option when you have already tagged a filing for a prior period.
- Create a new filing based on an existing filing for a different filer.**
Use this option where you have already tagged a similar filing (for example, for another company in the same group).
- Create a new read-only filing from iXBRL.**
Use this option to create a base filing to improve suggestions for a new filing.

Seahorse allows users to roll-forward their tags from one period to the next, reducing the ongoing effort in producing the iXBRL report. You can even load in iXBRL that was produced in other software to roll-forward from.
